Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Kachari Road near Hospital More without any valid documents causing obstruction to public way.

Sir,

I SI Malay Bhusan Chanda of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 30.06.23 around 12.25 hrs, while on duty at Hospital More found one TOTO without any registration number stationed near Kachari Road near Hospital More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Sanat Kumar Saha (23yrs) S/O Pankaj Saha, Purba Fakdaibari, PS-Bhaktinagar, Dist-Jalpaiguri. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
