Sub : Complaint against Abhijit Ghosh (Mobile 9064810200), Laxman Prasad (Mobile 9832093547), Bishnu Paul (Mobile 9832658590), Sushil alongwith four other unknown person for extortion of a sum of Rs. 7000/- by putting in fear of death of my husband and my children, outraging my modesty, threat to commit rape and for their other illegal acts and activities.

Respected Sir,

I, Jhuma Sha (Gupta), wife of Amit Kumar Gupta, resident of Shaktigarh, Road No. 6, Ward No. 31 of Siliguri Municipal Corporation, P.O Siliguri Bazar, P.S. NJP, Dist. Jalpaiguri would like to state that I alongwith my husband and children is residing at a rented flat at the address mentioned above. That in the year of 2020-2021 my husband namely Amit Kumar Gupta, son of Jay Prakash Gupta, was carrying the business of "Food Grain -Wholesale" as such was taking the goods from IZONE RETAIL VENTURES PVT. LTD, registered Office- K-8, Naveen Shahdara Delhi 110032. That Abhijit Ghosh was the area sales manager of IZONE RETAIL VENTURES PVT. LTD and due to fraud committed by said Abhijit Ghosh my husband sustained loss in such business as such he close the said business and went to outside of Siliguri for doing a private job and occasionally visit us as such I alongwith my two children is residing alone at the address mentioned above. That on 28.06.2023 at about 5.30 p.m. Abhijit Ghosh had send few miscreants namely Laxman Prasad (Mobile 9832093547), Bishnu Paul (Mobile 9832658590), Sushil alongwith four other unknown person, who

was the employee of IZONE RETAIL VENTURES PVT. LTD and was working under the said company in the year of 2020-2021 under Abhijit Ghosh came in a car and forcibly entered into my said rented flat and instructed me to asked my husband to provide them a sum of Rs. 2,00,000/- (Rupees Two Lakh) only which was due and payable by my husband to them. I requested them that I do not know anything regarding the said issues as such you have to talk with my husband for the same. But they became furious and threatened me that they will kidnap my both children from their school who are aged about 10 and 5 years respectively and also showed me photograph of my both children in their mobile phones and even threatened me that they will also kidnap my husband and kill him if we will not give them said sum of Rs. 2,00,000/- (Rupees Two Lakh) only. That I requested them not to do such illegal acts and activities but they are stubborn touched me inappropriately, pull my hair but somehow I tried my level best to save myself in their hands as such they asked me a sum of Rs. 20,000/- at that point of time or else they will rape me and kidnap my husband and children as such due to fear I had to give them whatever money I had at that point of time as such I provide them a sum of Rs. 4,000/- and they left my house saying that they will come again if we do not provide them a sum of Rs. 2,00,000/-.

Under the above circumstances I hereby lodging this complaint against the abovenamed wrongdoer and would request you to kindly investigate the matter and do the needful as soon as possible in this regard so that wrongdoer can be punished as per the procedure established by law.
