Sir,

I the undersigned would like to inform you that I belong to schedule tribe community. The Government of West Bengal has given a Patta vide settlement case no.38/XII/07 SL.NO.1 in respect of the land measuring 0.08 Acre, recorded in Khatian no. 279, in plot no.117, Mouza- Uday Singh, J.L.No.51, P.S. Matigara now Pradhan Nagar, Dist- Darjeeling, to me and I have constructed a dwelling house on the aforesaid land and started to residing there since the year November, 2021. Since the construction of my dwelling house my next door neighbour Sri Joseph Chakraborty son of late Khagesh Chakraborty started to harrasing me by different ways with intention that I shall not construct dwelling house at his adjacent land. He openly in front of many people several times stated that he don't wants a lower caste tribal person reside as his next door neighbour, though his wife is a tribal lady. Aforesaid Joshep Chakraborty since I started my home construction several times demolished my construction, threatened the construction workers so that they are not work, stealing electricity from my premises (I have lodged FIR against him regarding stealing electricity on 06.02.2022), several times spoils cement by pouring water and so many different ways he harassing me. But I didn't lodged any complaint against said Joseph with wish that one day every thing will be normal.

Sir, since last 15/16 days he is trying to close my ingress and egress road by keeping big boulders or blocking one side of Gate and also trying to encroach some portion of my land and whenever I raised objection he used slang abusive and insulting languages towards me and threatened me for dire consequences. He anytime insulted me and my family members by saying " Shala Adibasir Bachha". Today i.e., on 30.06.2023 at about 7:30 a.m. Pradhan Nagar police came to inquire on the basis of my complaint dated 28.06.2023 and after return back the police personnel, the aforesaid Joseph Chakraborty, his wife, daughter and one person named Shivam who staying with Joseph Chakraborty, all came

to my house and called me and when I came out they all physically assaulted me and hearing my cry my sister-in-law Smt. Sunita Tamang wife of late Pradeep Tamang came out from my house to rescue me. They also assaulted her and me by fist, blows, kicks and bamboo stick. Hearing hue and cry the neighbouring local people came to the spot and rescue us. Joseph Chakraborty threatened as well as insulted me by saying that "Saala Sanu jaat ko Manche talai ma mararera Jamin ma gari dinchu" and aforesaid Shivam showing me a knife (Khukuri) told me that he will cut me and my family into pieces within 24 hours. Thereafter they left the place due to interference of local people.

Sir, me and my family members are too much afraid and feeling lack on insecurity. Aforesaid Joseph Chakraborty and Shivam both are very notorious and dangerous type of persons and they can do any thing with us.

I therefore request you to kindly take immediate appropriate legal action against the aforesaid accused persons otherwise any time any untoward incident will be happened with us by aforesaid persons.
