Respected Sir,

I, **PRADIP CHOWDHURY**, S/O Late P.N. Chowdhury, Resident of Baghajatin Colony, P.O. & P.S. Pradhan Nagar, District - Darjeeling, Pin-734003, would like to lodge this written complaint to the effect that :-

1. That I am a peaceful and law abiding citizen of India.
2. That I am the supporter of a specific political party and I being the member of the political party I need to attend meetings as well as rallies.
3. That I being one of the political leader of the specific political party, there are many whatsapp group for our easy conversation and discussions with the other members of political party.
4. That from last few weeks I observed that one **Sri Biswadeep Ghosh, S/O Vishwanath Ghosh**, residing at Baghajatin Colony, Pradhan Nagar, in connivance with other persons started to pass derogatory comments with an intention to malign my political carrier and also started upload defamatory videos, vulgar messages in those whatsapp political groups and the said message widely got circulated in our various political groups to tarnish my political carrier.

That after that when I protested against these illegal acts and conducts of the said person namely **Sri Biswadeep Ghosh, S/O Vishwanath Ghosh**, along with his associates then the said person namely **Sri Biswadeep Ghosh, S/O Vishwanath Ghosh**, along with his associates started to abuse me with filthy languages and abuse upon my cast by uttering that "TUI CHOTOLOK MATHORER BACHHA" and also abuse me that I being a lower caste, will clean his latrine by my own hand and also threat me I


will lick feet with my tongue of the said person namely **Sri Biswadeep Ghosh, S/O Vishwanath Ghosh.**


