Sir,

In producing herewith one accused person named Umesh Mandal(37y/M), S/O. Kamal Mandal of Siliguri Junction, PS Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure.

1. 12 (Twelve) bottles of BUDWEISER PREMIUM BEER (each bottle containing 650 ml, Total 7.8 liters) marked as exhibit A and 01(one) bottle taken as sample for examination marked as exhibit A1.

I, ASI Biplab Kr. Das of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person namely Umesh Mandal(37y/M), S/O. Kamal Mandal of Siliguri Junction, PS Pradhan Nagar, Dist. Darjeeling to the effect that today on 30.06.2023 at 17.35 hrs. received a source information that one man has been selling and storing huge quantity of illicit liquor without any valid license at Rambilas hotel near Siliguri railway station under Pradhan Nagar PS.

Accordingly, I informed the matter to your good notice and as per your kind direction I along with C/762, Mojibul Rahman and CV/ 128. Ajay Kr. Sahani had been to Siliguri Junction under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that one man at Rambilas hotel near Siliguri Railway station was selling illicit liquor to the customers illegally for his wrongful gain. Subsequently, I along with my force cordoned the house and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as mentioned above.

Further being searched the above noted seized articles were found in house from his possession. On demand he failed to produce any valid license/papers for the articles which was recovered from his possession. On further interrogation he stated that he was involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized and labeled the above mentioned illegal illicit liquors under proper seizure list in presence of witness and arrested the above-mentioned person named Umesh Mandal(37y/M), S/O. Kamal Mandal of Siliguri Junction, PS Pradhan Nagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19.25 hrs to 20.05 hrs at the spot and arrested him after informing the ground of arrest. This refers to Pradhannagar Ps GDE no. 1905, Dt. 30.06.23.

I, therefore pray before your good self that a specific case may kindly be initiated against Umesh Mandal(37y/M), S/O. Kamal Mandal of Siliguri Junction, PS Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
