Sir,

With due respect and humble submission, I SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodge this written complaint after producing herewith the seized articles viz:- (1) 12 bottles of Himalayan FATAFATI country spirit each bottle containing 300 ML (2) one used bottle of Old Monk deluxe Rum containing 750 ML (3) One used bottle of Royal stag whiskey (4) One used bottle of Blinder spride (5) One used bottle of Royal Blue whiskey (6) One bottle of Kingfisher strong beer containing 650ML and (7) One bottle of used Imperial Blue which was packed in one big nylon bag to the effect that on 01.07.23 at 18.35hrs received a source information from Rajphapri near BSF gate under Bhaktinagar PS that one person namely Prabin Louis was selling wine in the open market for his wrongful gain without any documents/license in his restaurant style as Louis Restaurant. Diarized the fact in GD vide Bhaktinagar PS GDE No- 1505 dated 01.07.23. As per your kind instruction myself along with ASI Dipak Karmakar, Const/1431 Dilip Barman, C/915 Chandra Prakash Adhikary, C/374 Debraj Biswas proceeded to the PO to work out the information. At 19.05 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his restaurant. Seeing the Police party the alleged person fled away from the PO. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from the PO after prepared proper seizure list. (The seizure was made in between 19.10 hrs to 19.40 hrs) During local enquiry it came to learn that the owner of the restaurant is Prabin Louis s/o Anthoni Lurdu Louis of Salugara, Durga Malla Road, PS Bhaktinagar Dist Jalpaiguri.

I therefore request you a specific case may kindly be started against the accused person namely Prabin Louis s/o Anthoni Lurdu Louis of Salugara, Durga Malla Road, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..


