Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Bidhan Road near Gostho Pal More without any valid documents causing obstruction to public way.

Sir,

I ASI Ajit Singha of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 01.07.23 around 16.05 hrs, while on duty at Gostho Pal More found one (1) TOTO without any registration number stationed near Gostho Pal More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Ajifar Rahaman (47 Yrs) S/O Md. Khalibuddin, Saheb Para ,P.O- Kamar Vita, PS- Bhaktinagar, Dist- Jalpaiguri. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the car observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
