I, Sidhart Kumar, son of Shrawan K. Dubey
would like to inform you that on 30th June of
2023 I went to my office on usual timing i.e.
10.00am and my neighbour cum landlord went to Anandalok
hospital for their son's treatment at around 4:00pm. When I
returned to home at 7:00pm along with my neighbours
I found that main boundary door was locked however my
rented flat's main door was open i.e. lock was
broken. Further when I moved to my room there I found
that my almirah's all 3 doors which were not locked
by the keys was open a lidge and hidden chamber's
key were also in the almirah.

I found that my brown laptop bag was missing
which contained my HP Laptop, its charger, mouse and
brother-in-law's documents related to his court case
was missing. Further I found that my gold ornaments
containing one gold chain, 2 gold rings and ₹3000 cash
was also missing from the locker.

I would like to bring to your notice that the
above incident took place at my rented premises located
at opposite Himcourse Bhawan, Pavitra Nagar, Champasari,
Siliguri 734003.
