In producing herewith the following two accused persons namely 1) Ranjan Chakrobarty(28y/M), S/O. Subhas Chakrobarty of Samarnagar, Battala, Ps. Pradhannagar, Dist. Darjeeling and (2) Sujit Choudhury (29y/M), S/O. Laxmi Choudhury of Darjeeling more, Rajibnagar, Ps. Pradhannagar, Dist. Darjeeling, as per arrest memo and along with the following seized articles viz.:

- (iv) ONE GREY COLOUR EPSON PRINTERS MODEL NO. M129H WITH WHITE COLOUR ROLE PAPER
- (v) ONE BLUE COLOUR HANDHELD CCD SCANNER BEARING NO. S8557
- (vi) ONE WIFI SSID JIO FIBER ROUGHTER MODEL NO. JCOW414, BLUE COLOUR WITH CHARGER

I, ASI Manoj Kr. Roy of Pradhan Nagar PS, Dist. Darjeeling do hereby lodge this complaint to the effect that on 01/07/23 at 20:45 hrs while performing Special mobile duty at Samarnagar received a source information that a online gambling with computer is going on in the house of one Ranjan Chakrobarty.

Accordingly, I along with C/762, Mojibul Rahman, CV/ 992, Jagadish Biswas, CV/ 645 Baban Das and CV/242, Rakesh Mangar all of Pradhannagar PS rushed to the place to work out the information. At 20:55 hrs we reached in front of the house of Ranjan Chakrobarty being identified by the source and cordoned the house with a strong reason to believe that an illegal gambling is going on inside. Accordingly, prior to the entering inside the house we summoned two available disinterested witnesses namely (i) Rajen Jha(26y/M), S/O. Shyam Jha of Samarnagar, Battala, Ps. Pradhannagar, Dist. Darjeeling and (ii) Choton Chakrobarty (27y/M), S/O. Subhas Chakrobarty of Samarnagar, Battala, Ps. Pradhannagar, Dist. Darjeeling and on request, they accompanied us during the whole search and raid session.

On entering in side the house of Ranjan Chakrobarty with the above mentioned witnesses, found the above noted accused persons were gambling with the seized articles with a view to wrongful gain to one and wrongful loss to another.

I accordingly seized the above noted articles as noted earlier from the joint possession of the two arrested accused persons noted above under proper seizure list in presence of witnesses and duly signed by them. And the two accused persons as mentioned above were arrested as they violated the rules laid down under section 3/4 of West Bengal Gambling and Prize Competition Act XXX of 1957 and they were taken into custody and memo of arrest were supplied to them apprising their ground of arrest. The whole seizure was made in between 21.05 hrs. to 22.10 hrs and this refers to Pradhannagar PS GDE No. 59, Dt.01.07.2023.

I, therefore, pray that a specific case may kindly be started against the above mentioned two accused persons under section 3/4 West Bengal Gambling and Prize Competition Act XXX of 1957.
