Respected Sir,

I, Tapas Bishui, son of Late Birendra Nath Bishui, Assistant Engineer & Station Manager, Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India, would like to lodge a complaint regarding damage of electric (LTOH) lines and property of WBSEDCL. At around 14:30 hrs on 01.07.2023 afternoon Power House Customer Care Centre received information regarding damage of electric lines in NH31 bypass, Gandhi Nagar, Near IG Office, P.S. – Bhaktinagar, Dist – Jalpaiguri. On reaching the site the maintenance van of Power House Customer Care Centre found that, one truck having **Vehicle No. – WB-17 6888**, had broken one (1) 8 mtr. PCC Pole along with LTOH line and caused other damages to the Electric lines which are the property of WBSEDCL. The total damages caused by the vehicle are approximately around Rs. 28,325/- (Twenty Eight Thousand Three Hundred and Twenty Five Rupees only).

So, you are requested to kindly initiate an investigation against vehicle no. – **WB-17 6888** under Section 139 of the Electricity Act 2003 amended on 2007 of India.
