**Sub:- Unlawful entry and broken lock of Dagapur Tea Estate's Sealed Quarter**

Dear Sir,

I am writing to bring to your attention a serious incident of unlawful entry that occurred at our Dagapur Tea Estate, which requires your attention.

On 30<sup>th</sup> June 2023, it was discovered that our ex-employee Mr. Nitai Krishna Mullick had unlawfully entered the sealed quarter within our premises and broken the lock, and taken some goods without informing the Management. On the 1st of February 2023, Mr. Nitai Krishna Mullick resigned from his position at our company. Several times Management informed him to Handover the quarter to the Management but he didn't do. Since he locked his quarter and occupied it until now, In response to this the management has sealed it. There was no legitimate reason for him to be on our property. The incident was brought to our attention by our Garden employees who noticed suspicious activity near the sealed quarter during their routine work. Upon further investigation, it was revealed that the lock securing the quarter had been forcefully broken.

This is for your information and necessary action. We trust that you will handle this case with the utmost professionalism and diligence.
