Pradhan Nagar Police Station under subsequently Power of Attorney was cancelled by me vide Deed No. I-687 dated 9th day of June 2015.
  - 2. That the said Jeevan@Jiwan Sonar sold a part of land measuring 5 katha in favour of Smt. Gita

to 31 Benon fund & Pradhan Nagar Police Station Inspector-In-Charge Siliguri Police Gommissionerate Mohanto Giri vide Deed No. 1919 of 2017 in plot No. 506 with the support of said General Power of Attorney which was cancelled one month before after execution.

- 3. That thereafter said Jeevan @Jiwan Sonar declared that the plot No. which was mentioned in the said General Power of Attorney was wrong and he mentioned that instead the plot No. 506 it would be 519.
- 4. That subsequently said Smt. Gita Mohanto Giri sold and transferred a land measuring 3 katha in Plot No. 519 under Mouza Karaibari, J.L. No. 39, within the jurisdiction of Pradhan nagar Police Station to and in favour of Bindya Subedi and Sandhya Chhetri vide Deed No. 28 of 2021 which was registered at the office of the ADSR Siliguri-II at Bagdogra.
- 5. That said Bindya Subedi and Sandhya Chhetri again sold and transferred the land measuring 3 katha in plot No. 519 under Mouza Karaibari, J.L. No. 39, within the jurisdiction of Pradhan nagar Police Station to and in favour of Bacchu Dutta vide Deed No. 11798 of 2022 which was registered at the office of the ADSR Siliguri-II at Bagdogra.
- 6. That the above named persons sold maliciously for illegal profit by the Attorney named Jeevan@Jiwan Sonar even after such general Power of Attorney was revoked on 09.06.2015.
- 7. That thereafter I have filed a Civil Case before the Ld. Civil Judge Junior Division at Siliguri being Title

Suit being No. 145 of 2023 which is pending before the Ld. Court.

- 8. That in the meantime the above named Bachuu Dutta doing construction over the below schedule land force fully for his illegal gain by violating the order of the Ld. Court.
- 9. That I am a women and my husband is also old and suffering from many ailments hence we cannot run here and there so few days back when on 05.06.2023 at about 10.00 am I went to the land to talk to those purchasers with utter shock I saw that some construction was going on the said plot of land and I came to know that after knowing that land is in dispute and I am the original owner of the said plot of land.

Under the above circumstances it is therefore requested you to take necessary legal actions against the above mentioned accused persons and others who are involved in this conspiracy for their illegal gain as per the course of law for the ends of justice and stop the construction work till disposal of the Suit.
