Sir,

I Josilin Chakraborty daughter of Joseph Chakraborty ~~son~~ of Salbari Naya Bushy, under Pradhan Nagar Police Station, Dist - Darjeeling, do hereby want to file a diary against 'Simon Lepcha s/o Parthok Siring Lepcha and Augustin Lepcha s/o Parthok Siring Lepcha because last night on 30th June, 2023 around 9:00pm to 9:30p.m, the above mentioned person came in our house with, 'Iathi iron rod and helmet' and when my father just came in house they all of a sudden started assaulting and hitting my father. After hearing argument me and my mother Jasbin Lepcha want to separate my father from the above mentioned person but they assaulted my mother also and she was bitten by helmet on her head and her hand was swollen so while she was hurt she couldn't stand up and sat on stairs so I went to separate and protect my father but inspite of knowing that I am a college student they touch my body and pushed and humiliated me. After they were continuously pushing and touching my body, Shibam Roy who is my father's relatives came to protect and separate my father, but they assaulted Shibam Roy and the above mention person punched Shibam Roy and caught his neck. And now they are trying to trap us and Simon Lepcha, Augustin Lepcha and their family member are threatening to that if they will find Shibam Roy on the way they above mentioned person will kill Shibam Roy. Simon Lepcha and Augustin Lepcha and other family member is threatening that they will kill our family and trap us. We tried to stop them but they kept on assaulting my parents and pushing me and touching my body. And thus it is request to start a specific criminal case against the above noted accused person to arrest them immediately.
