I, the undersigned Complainant, Meena Kama d/o

Lt. Linder Singh Kama, residing at M.E.S Colony, Bagdogra,  
PIN- 734014, do hereby lodge this complaint and would  
like to bring your kind attention towards and an  
untoward situation as follows -

1. Today around 8:30 a.m, I was doing my morning  
chores, I was sweeping the back portion of my house  
and at the same time the accused herein was  
passing by- and suddenly passed sexually coloured  
remarks thereby provoking me to get into a verbal  
fight. The moment I tried to correct his actions, he  
and his wife suddenly attacked me and my old  
mother who recently went through a eye cataract  
surgery. Both accused and his wife verbally and  
physically abused me.

2. The accused herein is my neighbour ~~for~~ <sup>in</sup> the past and have known him all my lifetime and this is not the first time he has committed a wrong and misdeed like this. Previously, in many occasions the accused has been found making unnecessary advancements. Often I have found that the accused has been following me whenever I am outside my house and has kept me under strict observation despite clear indication of disinterest shown by me. On many occasions, I have discovered that he has been taking photographs in a discreet manner which has further made me feel insecure each and everytime. Moreover he has also been found making unnecessary comments and <sup>hand</sup> gestures which has intruded my privacy, disrupted my mental peace and has caused harm towards my personal life as well.

I would like to state, I live with my widowed mother, 75 yrs old approx. and my widow sister-in-law ~~along~~ along with two small kids. It is to be taken into account that ~~no~~ no adult male member live with us and thus the accused doesn't miss any opportunity to harass me and my family members, be it sexually, verbally or physically. The habitual behaviour of the accused has put me and my family at risk.



4. Earlier, I tried to lodge complaint but the accused works at Siliguri Court as a clerk and has threatened me of dire consequences if I speak a word against him. He said that he will use his influence and contacts to harass me.

5. Two police officers also visited the spot around 9:40 a.m. Many eye witnesses were also present at the place of incident who have faced similar situations just like me.

Under such critical circumstances, I hereby pray and request you to kindly look into this matter very seriously and accept this instant complaint and treat the same as the First Information Report.
