I, Smt. Saumaya Rai, w/o Sri Bhakta Bahadur Rai
Permanent resident of Police Colony, P.O. & P.S.
Bagdogra, Dist. Murshidabad, West Bengal, do inform
you that I am the registered owner of my own
purchased land wherein I have built a three
storied house.

On 20/06/2023 at about 9:20pm Vandana Rai
(Vandana Kumari Saha) quietly entered my house
which was under lock and key, with the help
of my tenants. And thereafter assaulted me
and my wife. And also abused and threatened
me, others and even physically assaulted me.

Tonight 29/06/2023 around 6:30pm Vandana
let in some unknown person inside the
building while I (Saumaya Rai) and my
family were outside. These people are
not known to me or anyone in my family.

They were stopped from entering the house by my son Gyanendra Rai and my son-in-law Rudra Day. These unknown person were not leaving the premise. Vandana was trying to forcibly bring in these unknown person

Around 5:49 pm Vandana Rai was still trying to bring these people inside. She was calling some more people to enter the building. One of the unknown person was also calling someone to beat up my son and son-in-law. Out of fear my son-in-law snatched the phone from Vandana and ran towards the balcony to prevent her from calling more people into the building to do physical harm on my son and son-in-law. The male member of the group rushed and physically assaulted my son-in-law. My son-in-law was injured and gave up the phone out of pain. Then this unknown group left due to my son Gyanendra Rai forcing them out.

Vandana was telling her people to go to police station and file a complaint. Vandana is threatening me and again that she will create such a situation in the house that you all will be bound to leave this world.
