Sir,

In producing herewith three (3) accused persons namely 1. Sanju Soren of Rangapani near Post Office PS Bagdogra , Dist. Darjeeling 2. Karan Singha (25) s/o Lt. Ajoy Singha of Rangapani Tetultola PS Bagdogra Dist. Darjeeling 3. Kabir Sheikh (24) s/o Lt. Raju Sheikh of Pramod Nagar PS Bagdogra Dist. Darjeeling along with seized articles viz

1. One iron made "Katari" having approx length 15 " inches including butt from the possession of accused Sanju Soren.
2. One Knife having length approx 12" inches including butt from the possession of accused Karan Singha
3. One iron made "Sabal" measuring approx 3 ½ feet from the possession of accused person Kabir Sheikh
4. Two electronic Torch light from the PO.

I SI Binup Mahato, Bagdogra PS, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 30.06.23 at 00-05 hrs received a secret source of information to the effect that 09/10 miscreants armed with deadly weapons assembled in a dark place at Hansqua More near Tea Garden under Bagdogra PS with a view to commit dacoity. Accordingly without waste any time I informed the matter to you and diarised the matter vide Bagdogra PS GDE No. 1597 dt. 30.06.23 and as per your kind instruction myself alongwith SI Laksnag Bhutia , C/851 Chandan Debnath , VP-01 Aansalam Kujur, CV-389 Janak Singha and also night van officer and force SI Pradip Kr. Sarkar C/540 Mintu Barua C/336 Gobordhan Roy Das left from PS for Hansqua More to verify the veracity of the information and to work upon it vide Bagdogra PS GDE No. 1598 dt. 30.06.23. We reached near the spot as confirmed by the source at about 00-55 hrs and stopped our vehicle at a considerable distance from that place and we started walking towards Hansqua More and found a group of 09/10 persons assemble and gossiping there and try to concealed in Tea Garden. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang see the police. Somehow, after a hot chase we could able to apprehend the 03 (three) persons noted above which is not verified and the others 06/07 persons managed to flee away from the spot . On interrogation they disclosed their identity and they also stated that they alongwith their other associates assembled there with a view to commit dacoity after making full preparation in the adjacent area of Hansqua Bazar under Bagdogra PS. Thereafter all the apprehended persons were searched and due to late night could not found any independent witness to present at the time of search and seizure. During searching I found and recovered the above noted articles from their possession and seized the same as per proper seizure list duly sign by them. Accordingly I arrested the above noted accused person u/s 41 Cr.P.C. The seizure and arrest made in between 01-05 hrs to 01-55 hrs and the all persons were arrested with proper memo of arrest.

So I pray before you that a specific case may kindly be started against the above noted 03 (three) accused persons and 06/07 other person and arranged for its investigation.
