Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Kachari Road

Sir,

I SI Malay Bhusan Chanda of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 03.07.23 around 10.48 hrs, while on duty at Kachari Road , Hospital More found one (1) TOTO without any registration number stationed at Kachari Road , Hospital More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed identity as Gopal Paul (55 Yrs), Mobile No-9733316792, S/O- Lt. Birendra Paul, of Bagha Jatin Colony , P.S-Pradhan Nagar, Dist-Darjeeling. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
