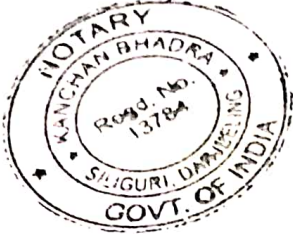

The humble petition filed on behalf
of the above-named complainant.

Most Respectfully Sheweth :-

- 1) That the above-named Complainant Smt. Supriya Ghosh is a senior citizen and a peace loving and law abiding citizen of India having her permanent place of residence at "Prarthanan", Kabiguru Sarani, Ward no-21 (S.M.C), P.O.-Rabindra Sarani & P.S.-Siliguri, Dist- Darjeeling, Pin-734006.
- 2) That the Complainant is the mother-in-law of Sneha Goswami (accused person No-1), who married his son Samiran Ghosh, on 27th January, 2023 at Pradhannagar, Deokota Sangha, Near State Bank of India, as per hindu rites and customs.
- 3) That the accused persons attempting to extort money² from complainant's husband Arun Kumar Ghosh, a senior citizen aged about 70 years and the complainant, as well as other family members.
- 4) That the accused persons have demanded Rs- 50,000/- (Fifty thousand) only and threatening the family members of the complainant with dire consequences if they do not comply with their demands. In fear of their threat the complainant handed over a sum of Rs. 30,000/- in cash to the accused persons and sought for some time to arrange the remaining balance.
- 5) That the accused persons has further threatened to falsely accuse the complainant and her family members in various crimes and register fabricated cases against them if they fail to pay the remaining money and other demands. These threats are completely baseless and intended to manipulate and intimidate them.

That on 09/06/2023, the complainant lodge a complaint before the Siliguri Police Station against the accused persons and as no specific case was started for the cognizable offence by Siliguri P.S as such on 13/6/23 a complaint was made before Commissioner of Police, which was duly received, but no investigation has been started against the above-mentioned cognizable offences committed by the above named accused persons. (copy of the written complaints dated 9/6/2023 and 13/6/23 are enclosed herewith being **Annexure-1 & 2**

- 7) That the police authority till today has neither registered the case nor took any action against the accused persons for the reasons best known to them.
- 8) That the acts and conducts of the above named accused persons have caused to the complainant's daily life and has resulted enormous mental cruelty, harassment, and sufferings by the accused persons. The complainant was mentally tortured, threatened by the accused persons for their wrongful gain.

Under the above circumstances it is therefore prayed that your Honour would be graciously pleased to pass necessary order/orders for directing the Commissioner of Siliguri Metropolitan Police/Inspector-in-charge of Siliguri Police Station to registered the aforesaid complaint as F.I.R. immediately under section 156(3) of Cr.P.C and investigate the matter.
