Sir,

In producing herewith one arrested accused namely Uttam Kr. Barman (39 yrs), S/O- Shambhu Ram Barman of Foudi Gach, PO- Buraganj, PS- Phansidewa, Dist - Darjeeling along with seized vehicle bearing Reg No. WB 76 G 6118 loaded with river bed materials along with relative documents I AS.I. Dharendra Nah Mandal of Matigara P.S, SPC do hereby lodge a Complaint against the above noted accused person to the effect that on 02.07.2023 at 08:00 hrs onwards during my mobile van duty I received an information from reliable source that one Dumper loaded with illegally mining riverbed materials coming from Tarabari Ghat side. On receiving the information I along with available force rushed to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at Haler Matha under Matigara P.S area, I found said Dumper bearing Reg No. WB 76 G 6118 loaded with river bed materials going towards Shivmandir. Subsequently, I manage to stop the vehicle and asked the driver to produce valid documents / papers of the said river bed materials, but he failed to produce any valid documents in support of said materials. As such I also seized the above noted loaded dumper under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses and arrested the driver namely Uttam Kr. Barman (39 yrs), S/O- Shambhu Ram Barman of Foudi Gach, PO- Buraganj, PS- Phansidewa, Dist - Darjeeling under proper memo of arrest and brought to the above noted vehicle at P.S. The whole seizure process was made in between 12:25 hrs to 12:45 hrs.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle namely Uttam Kr. Barman (39 yrs), S/O- Shambhu Ram Barman of Foudi Gach, PO- Buraganj, PS- Phansidewa, and Dist - Darjeeling and the seized vehicle bearing Reg No. WB 76 G 6118 under proper section of law and arrange for its investigation.
