Sir,

In producing herewith one arrested accused namely Parimal Barman (36 yrs), S/O- Lt. Nanda Barman of Goyaljote, PO- Nema, PS- Matigara, Dist - Darjeeling along with seized vehicle bearing Reg No. WB 73 F 0562 loaded with river bed materials along with relative documents, I S.I. Agen Lepcha of Matigara P.S, SPC do hereby lodge a Complaint against the above noted accused person to the effect that on 02.07.2023 at 12:02 hrs onwards during my special mobile van duty I received an information from reliable source that one Dumper loaded with illegally mining riverbed materials coming from Tarabari Ghat side. On receiving the information I along with available force rushed to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at Haler Matha under Matigara P.S area, I found said Dumper bearing Reg No. WB 73 F 0562 loaded with river bed materials going towards Shivmandir. Subsequently, I manage to stop the vehicle and asked the driver to produce valid documents / papers of the said river bed materials, but he failed to produce any valid documents in support of said materials. As such I also seized the above noted loaded dumper under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses and arrested the driver namely Parimal Barman (36 yrs), S/O- Lt. Nanda Barman of Goyaljote, PO- Nema, PS- Matigara, Dist - Darjeeling under proper memo of arrest and brought to the above noted vehicle at P.S. The whole seizure process was made in between 12:55 hrs to 13:10 hrs.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle namely Parimal Barman (36 yrs), S/O- Lt. Nanda Barman of Goyaljote, PO- Nema, PS- Matigara, Dist - Darjeeling and the seized vehicle bearing Reg No. WB 73 F 0562 under proper section of law and arrange for its investigation.
