Sub: Intimation of incident of theft by unauthorised entry into the Company's shop  
at Municipal Holding No. 248/1, Nivedita Road, Siliguri by unknown miscreant

I, Nikhil Ranjan Ranjan Ghosh S/o Nitya Gopal Ghosh aged about 50 years permanent resident of Village  
Bhonda, Karamkal, PS - Sadaipur, District Birbhum - 731126, presently residing at H/o Smt Tusha Roy,  
Matigara, Simultala and also Head of the Operation, Siliguri Unit of the Company hereby inform you  
that today at about 7:53 A.M. our shop assistants namely Ashadur Rahaman and Rohit Kumar Singha  
opened the above shop and at about 8:00 A.M. when they opened the locker inside the shop found that  
a sum of Rs.17,489/- (Rupees Seventeen thousand four hundred eighty nine) is missing from the said  
locker.

And they also found that the following products are missing from the shop premises:-

- 1) Cigarette Wills Navy Cut - 4 Packets @110/- each amounting to Rs. 440/-
- 2) Cigarette Gold Flake Premium - 1 Packet @95/- each amounting to Rs. 95/-
- 3) Cigarette Gold Flake King Size - 11 Packet @ 340/- each amounting to Rs. 3740/-
- 4) Cigarette Wills Classic Rich Taste - 1 Packet @170/- each amounting to Rs. 170/-
- 5) Cigarette Gold Flake King Size - 12 Packet @170/- each amounting to Rs. 2040/-
- 6) Cigarette Gold Flake Kings Blue - 5 Packet @340/- each amounting to Rs. 1700/-

The aforesaid cash amounting to Rs. 17,489/- is Company's money generated from the sales of the said  
shop on 29-06-2023 and which has been set aside by the staff members of the Company in the iron  
safe/locker within the shop on 29-06-2023 at about 9:50 P.M. during closing of the shop in presence of  
other staff members. And the cash value amounting to Rs. 8,185/- of the above products stolen from  
the shop are also Company's goods and property.

The iron safe and all shutters of the shop duly closed and locked at about 10:00 P.M. The keys of the  
iron locker kept in the drawer of the cash counter inside the shop room and keys of the shutter kept  
with the staff members of the shop at their mess from 10 P.M. to 7:50 A.M.

As per CCTV footage of the above incident I confirm that the said cash, goods and property of the  
Company has been theft from the Company's shop premises situated at Municipal Holding No. 248/1,  
Nivedita Road, Siliguri by unknown miscreant.

Therefore, I would request your goodself to Diarise/FIR the incident and investigate the matter and  
recover stolen money, goods and property of the Company.
