Subject: FIR

In producing herewith three (03) arrested accused persons namely (1) Saibal Dey Sarkar (29), s/o - Nilay Dey Sarkar, of - South Santi Nagar, PO - Dabgram - II, PS - New Jalpaiguri, District Jalpaiguri (2) Dipak Barman (23), S/O - Indrajit Barman, of - Madhab Danga, 1 No Gram Panchayet, PS - Maynaguri, Dist - Jalpaiguri & (3) Razzak Islam (28), S/O - Faridul Islam, of - Surja Sen Colony, More Bazar, E - Block, PO + PS - NJP, Dist - Jalpaiguri arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron rod measuring 32 inch (approx) in length from the possession of Saibal Dey Sarkar which was kept on his right hand.
- (2) One iron rod measuring 26 inch (approx) in length from the possession of Dipak Barman which was kept on his right hand.
- (3) One sharp cutting Knife with wooden handle measuring 12 inch (approx) in length from the possession of Razzak Islam which was kept on his right hand.
- (4) One Torch Light from the possession of Saibal Dey Sarkar.

I, SI Ganesh Roy of NBMC OP under Matigara P.S, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that on 04.07.2023 at 00.35 hrs received a source information that 10/12 youths have assembled at Kawakhali Selimghat under Matigara PS with a view to commit dacoity at Kawakhali area. The fact was diarized in GDE vide NBMC OP GDE No-77 Dated 04.07.2023. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Amal Roy, ASI Dalal Dey, ASI Pradip Singha, C/1085 Mithun Debnath, C/327 Barkat Ali Ahmed, and VP -06 Nitish Singha left for the place to work out the information at 00.45 hrs with Govt vehicle bearing registration no WB 74 Q 8035. This refers NBMC OP MCC No 850 Dated 04/07/2023 and NBMC OP GDE No-78 Dated 04.07.2023.

At about 01.05 hrs after reaching at Kawakhali Selimghat under Matigara PS, I met my source and as pointed by the source we started approaching towards the spot and cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence. But, seeing the police party approaching towards them they tried to flee away from the spot. On hot chase we managed to apprehend three accused persons along with seized articles from their possession as mentioned above who disclosed their name & address as (1) Saibal Dey Sarkar (29), s/o - Nilay Dey Sarkar, of - South Santi Nagar, PO - Dabgram II, PS - New Jalpaiguri, District Jalpaiguri (2) Dipak Barman (23), S/O - Indrajit Barman, of - Madhab Danga, 1 No Gram Panchayet, PS - Maynaguri, Dist - Jalpaiguri & (3) Razzak Islam (28), S/O - Faridul Islam, of - Surja Sen Colony, More Bazar, E - Block, PO + PS - NJP, Dist - Jalpaiguri
