

3. That on 07.06.2023 the complainant along with one Swaran Chandra Mandal, son of Lt. Gopal Mandal, went out driving the above referred vehicle towards Champasari.
4. That around 12.30 p.m. the complainant went inside the Regulated Market at Champasari More, leaving the vehicle beside the road with said Swaran Mandal.
5. That all of a sudden Swaran Mandal called the complainant saying some people were trying to take the vehicle with them and when the complainant came back, Swaran Mnadal said that four people had come to the spot and forcefully dragged him out of the vehicle by grasping his collar and threw him beside the road and they went away taking the car with them by saying "MALIK KO BOLDENA COMPANY GADI UTHA LIYA".
6. That the complainant searched everywhere possible for his vehicle for several days and ultimately he came to know that his above-mentioned vehicle was standing at Sunny Parking, situated at Shalugara, near SBI ATM.
7. That thereafter I lodged a written complaint before the Commisionerate of Police, Siliguri Police Commissionerate, on 10.06.2023, informing about the said incident but till now the concerned department has taken no action thus finding no other alternative the complainant has brought the present complaint before the Ld. Court.
