The above mentioned persons reached my house from
a vehicle bearing registration No- BR 07 PB 7833 Scorpio
and they broke the main gate of my house & entered

unlawfully in my house and that time i and my younger son is out of my house and only my wife is in my house. That at approx 5.00 P.M. the above mentioned persons entered in my main room & broke the locker and snatched all gold & silver belongings of my wife and they also snatched cash amount of 25,000/- (Twenty five thousand) they also abused & mistreated with my wife and snatched her mangalsutra. That they also beat my both younger son with illegal arms & weapon which they carried for their ill motive my younger sons sustain multiple injuries on that. That they robbed all valuable belonging of my house. It is also prominent to mention here that today they forced my younger son in sibirgi junction & threatened him for size consequences.
