Subject: F.I.R.

With due respect and in producing herewith the arrested accused person namely 1) Asif Gulshan S/o Md Munna of City Teghoria PO& PS Kishanganj Dist. Kishanganj Bihar 2) Md Sakil S/o Lt. Md Akhlak of Mithapur PO& PS Dalkhola Dist Uttar Dinajpur with following seized articles :-

- 1. One vehicle Dumper bearing Reg. No. WB 73 G 0686 loaded with river bed materials.
- 2. One vehicle Dumper bearing Reg. No. WB 73 G 0386 loaded with river bed materials.

In this regard, (PS) Avijit Banik of Matigara P.S, SPC do hereby lodge this Complaint against above named arrested accused persons to the effect that on 05.07.2023 at about 23:00 hrs onwards I received a source information that two vehicle (Dumper) bearing Reg. No. WB 73 FC0686 & WB 73 G 0386 loaded with river bed materials coming from Balasan River ghat side towards Matigara without any valid documents. Accordingly I inform the fact to Officer In charge Matigara PS and as per his kind direction I along with force had been to Tumbajote near Petrol pump under PS Matigara to work out the information in hand. After arrival of the spot, I found said vehicles bearing Reg. No. WB 73 FC0686 & WB73G0386 loaded with river bed materials going towards Khatibakhari side under Matigara PS area. Accordingly, I apprehended the driver of the vehicles. On asking they introduce themselves as 1) Asif Gulshan S/o Md Munna of City Teghoria PO& PS Kishanganj Dist. Kishanganj Bihar 2) Md Sakil S/o Lt. Md Akhlak of Mithapur PO& PS Dalkhola Dist Uttar Dinajpur. On demand they failed to produce any valid documents in respect of river bed materials loaded in their vehicles. On further interrogation, they stated that he mines such river bed materials from Balasan River Ghat by illegal means with a view to sell the same for his illegal gain. Accordingly I seized the above noted vehicle loaded with illegally mining river bed materials under proper seizure list from their possession and arrested them after maintaining all formalities and file report.

It may inform you that a specific case under proper section of law may kindly be registered against the arrested accused persons namely 1) Asif Gulshan S/o Md Munna of City Teghoria PO& PS Kishanganj Dist. Kishanganj Bihar 2) Md Sakil S/o Lt. Md Akhlak of Mithapur PO& PS Dalkhola Dist Uttar Dinajpur of the vehicle and arrange for its investigation.
