SUB: First Information Report

Sir,

With due respect, I am producing herewith one Accused Namely Jhai Besra (43) s/o Lt Sreelal Besra of Koraihari PS Pradhannagar Dist Darjeeling Under arrest along with seized one Tractor having Registration no WB 73 F/7574 loaded with River bed materials.

I beg to report that on 07.07.2023 night I was engaged in mobile van duty PS area, with CV 883 Ananta Roy CV 646 Baban Das, I was patrolling near Milan more area under Pradhan Nagar PS and found that above noted Tractor loaded with river bed materials coming from Milan More area, I told him to stop the vehicle but driver did not pay any heed to me and tried fled way with his vehicle, Somehow we chase him and stop the above noted bolero-pick-up and detained the driver. On interrogation he disclosed his identity noted above. I asked to the above noted drivers to produce any document in respect of loaded river bed materials and vehicle paper, but he failed to produce supporting document regarding said vehicles .He also stated that they loaded the said sand Stone (Riverbed materials) from Uttar palash ghat Under Pradhan Nagar P.S illegally for his wrongful gain ,So I arrested him U/S 41 Cr.P.C and seized the loaded vehicle under proper seizure list. Seized in between 06:30 hrs to 07.15 hrs of 08-07-2023.

Therefore, I pray before you that a specific case under proper section of law may kindly be Initiated against the accused persons viz: Jhai Besra(43) s/o Lt Sreelal Besra of Koraihari PS Pradhannagar Dist Darjeeling and arrange for its investigation.
