I, **CHANDAN SUTRADHAR**, Son of Debnath Sutradhar, Resident of West Hatiyadanga, Radha KRISHNA Pally, P.O. Sahudangi Hat, P.S. Ashigarh Out Post, Dist. Jalpaiguri, West Bengal, do hereby want to inform you as follows: -

1. That I am the permanent resident of the above mentioned address.
2. That I had lodged this FIR with effect that my nephew namely Pranay Sarkar, Son Late Tapan Sarkar, who is an orphan as his parents died when he was at the age of 3 years and after that he used to reside with us.
3. That on 03.07.2023 at around 9:30pm while my nephew namely Pranay Sarkar was returning from his computer tuition by his cycle towards my house situated at the above mentioned address, and when he was going reach the bridge between the Kankata More and Jaleshwari near Airtel Building, suddenly one person namely **RIJU BISWAS**, S/O Mirtunjay Biswas of Thana More, P.S.Siliguri, Dist. Darjeeling was riding Honda Scooty being no. **WB 74BF 1068**, by triple loading, coming from Kankata More going towards Jaleshwari, ridding rashly on high speed came and towards my nephew and hit bicycle, due to severe hit my nephew was throw away at a long distance.
4. That thereafter my nephew was severely injured, deep cut below his right eye, left ear got severely injured as well as his whole body was injured and he was besmeared with blood.
5. That subsequently the local people took my nephew on a toto and when I received the information, I rushed towards the said spot and admitted my nephew at Siliguri Hospital at about 10:00pm.

stiches on various parts of his body, legs are injured severely, unable to move and he was at the Hospital for 2 days and was discharged on 05.07.2023 and is in bedridden condition.

7. That subsequently due to the engaged in the treatment of my nephew, I and my family members was unable to lodge F.I.R. against the said vehicle bearing Registration No. **WB 74BF 1068**.

8. That at present I and my family members are in helpless condition and I humbly pray before to kindly take strict action against the said **RIJU BISWAS**, S/O Mirtunjay Biswas of Thana More, P.S. Siliguri, Dist. Darjeeling and I and my family members are in a helpless situation where we are passing our days with tremendous hardships.

I therefore request before your good self to kindly look into the matter and take necessary strong action against the said **RIJU BISWAS**, S/O Mirtunjay Biswas of Thana More, P.S. Siliguri, Dist. Darjeeling as per the provision of law and for this act of kindness I shall remain extremely great full to you.
