Sir,

I, ANAND THAPA, son of Late Man Bahadur Thapa, resident of Vill. Kalanjole, P.O. Sushrutnagar, P.S. Maligana, Dist. Darjeeling, would like to inform you that I am a sole and absolute owner of one recorded homestead land measuring 2.5 Katha or 0.04 acre, situated within the Mouja - Kalam, being Plot No. 62 (L.S), 71 (L.R.), Khalian No. 1395 (L.R.), F.L. 76, under Maligana Police Station, Dist. Darjeeling. I reside here since ten years along with my family members. One NIRMALA THAPA, wife of Sri. Kishore Thapa, resident of Vill. Kalanjole, P.O. Sushrutnagar, P.S. Maligana, Dist. Darjeeling, who is my neighbour (residing beside my house), is trying to occupy the half of car-parking area measuring more or less 69 sq. ft of my aforesaid residential plot since 30.06.2023. Today i.e. 10.07.2023 at about 11:30 A.M., while my labours tried to dig a trench in my presence over my aforesaid land for the purpose of constructing boundary wall, said NIRMALA THAPA obstructed my labours illegally and when I tried to know the reason of her obstruction she became furious and started to hurt abuse with slang and filthy language to me and my family members and also threatened me that if I again try to dig a trench over my land she shall lodge a false case against me.
