the following facts:-

1. That Sri Rohit Kumar Mahato, S/O, Sri. Shib Shankar Mahato,
resident of Adarsha Nagar Colony, Champasari, P.S:-
Pradhan Nagar, District:- Darjeeling, Pin:734003, (W.B) is my
legally married Husband. Our marriage was solemnized on
18th August 2017 in according to Hindu rites and customs in
presence of the relatives, friends, well wishes of both the
parties.

2. That after marriage, we started to live/ reside there together
as Husband and wife at my in-laws house for couple of
months, subsequently, after consecutive seven months, my
above named husband and my in-laws have/had started to

rigorous torture upon me, during that tenure, most of the days I was living with immense starvation.

3. That I have/had compelled to leave from my above noted matrimonial house with my husband due to mental and physical assault upon me by my husband and said in-laws.
4. That after shifting to rented house from matrimonial house (details as stated above as my present address). Most of the times my in-laws came to my rented house and used to talk abusive words purporting that **"rendy, magi tui onno bhatarer sathe lagiye nijer pet chala, saradin kar hol a dhuke thakis, kake chudis chodna?"** in the presence of my husband, but on the other hand my husband could not be protested against such types of vulgar statements of said in-laws. Thereafter, they were started to physical torture upon me.
5. That it is pertinent to mention here that my in-laws with my husband have/had compelled to sell my own purchasing land measuring 1.5 kathas and after selling the said land my in-laws illegally grabbed entire selling amount of Rs. 8, 00,000/- (Rupees Eight Lakhs), (which is total consideration selling amount of the said land) ,but they had not gave any single amount of money to me, thus they did cheating upon me.

6. That on previous day i.e. 07/07/2023 at about 1 a.m (at night) my said alleged husband suddenly started to physical assault upon me by slapping, catching my hair's log and used criminal force upon me and he also caused to felled down on the earth and caught me wearing apparel night ware and pulled the same and also physically assaulted me by fist and blows with kicks.
7. .They threatened me by saying that if I do not withdraw the said case, then they will murder me and my parents and set fire my father's house. I received severe pain injury on my body for their such assault and thus, he was committed brutally assaulted upon me.
8. That thereafter, I have/had raised hue and cry. Then, my alleged husband decamped from there but before decamping , he snatched my gold neck chain weighing 1 (one) bhoari from my neck alongwith my all belonging articles viz: Original Voter Card, Original Aadhaar Card, Two ATM Cards, Original Pan Card, Original Health Card, issued by Govt. of West Bengal from my safe custody. Moreover, he also took Rs. 50,000/- (Rupees Fifty Thousand) in cash amount from my vanity bag in table,(where I kept the same). Even though, before leaving the spot, he also threatened me he will murder me and my entire family members, if I or my

family members lodged any complain before any authority against him.

9. That for that reason, I received/ sustained injuries and suffered bodily pain on our respective body due to such assault.
10. That due to his such acts and activities and threatening me by my husband and my in-laws for continuously, thereby, I am passing my present days with great fear and heard ship & triggering stigma yet.

I, therefore, request you to kindly take necessary legal steps against them and would be arrested of all allege persons after initiated a specific criminal case against all of them as soon as possible for their commission of the aforesaid offences upon me for administration of justice.
