1. Smt Raj Kumari Devi W/o Late Raj Kumar Yadav, resident of New Pokaijote, Champasari, P.S - Pradhan Nagar, Siliguri, District - Darjeeling, would like to inform you that Yesterday i.e. 8 - 7 - 2023 at about 9.30 p.m when my sons Sri Shyam Yadav and Nitesh Yadav both are sons of Late Raj Kumar Yadav and my brother in Law Ramjapo Yadav S/o Late Rashik Lal Yadav were returning from Regulated Market after closing their business establishment and when they were about to reach house at Pokaijote, Champasari, Pradhan Nagar, Darjeeling, a group of antisocial elements namely 1) Sri Rampukar Yadav, 2) Ram Narayan Yadav both are sons of Dukha Yadav, 3) Dhiraj Yadav, 4) Raj Kumar Yadav, 5) Ramesh Yadav all are sons of Ram Narayan Yadav, 6) Sandip Yadav, 7) Ranjit Yadav both are sons of Ram Pukar Yadav, aal are resident of New Pokaijote, Champasari, P.S - Pradhan Nagar, Siliguri, District - Darjeeling, 8) Uma Shankar Yadav S/o Kailash Yadav, 9) Lalan Mukhiya S/o Satya Mukhiya 10) Mukesh Mukhiya S/o Rajendra Mukhiya, 11) Binod Yadav S/o Lila Yadav, 12) Lila Yadav S/o Raghuni Yadav, 13) Shib Narayan Yadav @ Bantha S/o Srilal Yadav, 14) Raju Yadav S/o Anandi Yadav 15) Hareram Yadav S/o Gangu Yadav alongwith other 4 - 5 persons name not known to me all are resident of Siliguri Regulated market. Siliguri Darjeeling but they are the permanent resident of different districts of the state of Bihar. When my sons and brother in law reached at Chourasata of New Pokaijote, all of a sudden the above named persons who have equipped with Talwar, wooden battam, Bamboo Lathi, rod, iron punch and stones have attacked them with intention to kill them, resulting which my both the sons and brother in law sustained serious injuries on their part and several stitches has took place on their hear and body and they became un concuss and after hearing hue and cry when I alongwith other local residents rushed to the place of occurrence, the above named persons fled away from the spot with threatening that they are the man of Dilip Barman and will finish the life of my entire family members and presently my both the sons and brother - in law are fighting for their life and death. I also came to know that the above named persons have attacked my sons and brother - in law upon the instruction and instigations of the local ward Councillor Sri Dilip Barman with whom since long a political revelry is going on with my son Shyam Yadav. I am afraid that in future the said Dilip Barman with the help of his goons and anti-social elements may repeat the same action with my family members.

So requesting you to investigate the matter and take necessary legal action against the above named persons. Due to busy in the treatment of my sons and brother - in law who are presently admitted at Siliguri Sadar Hospital, I could not lodge my FIR within time.
