Dear Sir,

This is to inform you that last night, on 07.07.2023 a theft has taken place at our Petrol Pump premises as was noticed by one of our staff members today morning. He noticed that the lock of one of the doors of a room in our staff quarters was broken and old records & Cash Memo books were found thrown all over the floor of the room. On further scrutiny we found that two steel trunks containing the records of our business were missing.

We immediately took cognisance of the situation and checked the footage of our CCTV camera system. At around 2:05 AM, two women, were seen entering our Petrol Pump premises, trying to break into our staff quarters situated at the rear side of the premises. After failed attempt to open the door, they entered the quarters after jumping over its boundary wall. They were seen walking briskly inside the place and after sometime were noticed walking away with two nos. of trunks (containing old records and cash memo books)after passing them over the wall of the quarters. Their movement has been recorded on multiple cameras, carrying the goods(packed in white bags) on their back, before exiting the premises of our petrol Pump.

We are extremely disturbed by the incident, and apprehend such occurrences in the future after having noticed the audacity of the culprits, despite our outlet being situated in the heart of the city, which is well lit throughout the night, even after working hours. Safety of our premises and staff has become a matter of worry and concern for us, now.

Your kind self is hereby requested to take immediate action in the matter to investigate and nab the culprits and arrest them and recover the stolen goods, which would also avert any similar situation that could ever arise in the future.
