Sir,

I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Santi Bhusan Nandi, Ph No- 9832025194, Sukanta Nagar, Near Auto-Stand, P.O. Rabindra Sarani, Siliguri, Dist- Jalpaiguri for having committed offence as stated here under.

On 11.07.2023 at about 02.45 p.m. acting on a source information I, along with 1) Sri Amarasish Mahandeo, DE(E), S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential building of Santi Bhusan Nandi and inspected service installation, metering installation of Consumer ID 412151972 in the name of Santi Bhusan Nandi. During inspection it was found that electricity was being supplied unauthorisedly & illegally for construction purpose from domestic connection to the nearby construction site.

As unauthorised construction uses from domestic service connection was detected the energy meter make Bente Electricals & Elec Ltd, serial no.- IPB247427 and two core PVC wire (10 mtr approx) installed against Con Id. 412151972 seized by preparing a formal seizure list duly signed by representative of Santi Bhusan Nandi and witnesses. The copy of the seizure list handed over to representative of Santi Bhusan Nandi and his signature obtained as token of receipt.

As Santi Bhusan Nandi have committed offence u/s 135(1)(e) of Electricity Act 2003 by using electricity illegally & unauthorisedly for construction purpose from domestic connection, you are requested to take cognizance of the same by treating this complaint as FIR. 
