Sub: - Complaint

Sir,

With due respect and humble submission I, SI Mrinal Basunia of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the owner and driver of vehicle No- WB73F/1312 (Tata Truck) Having Engine No-5LNGDICR17EPY504210 & Chassis No-MAT764011K7E10224 to the effect that on 12.07.23 at 18.35 hrs received a source information from Bikashnagar near Forest ground, PO Salugara under Bhaktinagar PS that one Truck bearing No-WB73F/1312 was standing loaded with huge quantity of Sikkim wine and just try to unload the same at Bikashnagar for selling the same in the open market for wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No- 1758 dated 12.07.23. As per your kind instruction immediately myself along with PSI Koushik Raha, ASI Dipak Karmakar, C/915 C.P.Adhikary, C/374 Debraj Biswas, proceeded to the PO to work out the information. Within twenty minutes we reached at the spot, sometimes after, being identified by the source our police party held raid and found 10 (Ten) paper cartoon wine was kept in a Truck bearing No-WB73F/1312. Seeing the Police party the driver of the vehicle no-WB73F/1312 fled away from the spot. On hot chase failed to arrest him but recovered and seized the following articles from the PO:-

- (1) 40 (Forty) bottles of ROYAL BLUE Premium Whisky (Made in Sikkim) each bottle containing 180 ML which was kept in three paper cartoon.
- (2) 35 (Thirty five) bottles of Kingfisher strong Beer each bottle containing 650 ML which was kept in three paper cartoon
- (3) 45 (Forty five) bottles of OLD Monk Deluxe Rum (Made in Sikkim) each bottle containing 180 ML which was kept in four paper cartoon
- (4) One Tata Truck bearing No- vehicle No- WB73F/1312 Having Engine No- 5LNGDICR17EPY504210 & Chassis No-MAT764011K7E10224

During local enquiry it came to learn that the name of alleged lady is Dipa Bhujel w/o Tamang w/o Kumar Tamang of Bikashnagar PS Bhaktinagar Dist Jalpaiguri and her driver. She is selling the same in open market since long for her wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from the PO (The seizure was made in between 19.10 hrs to 21.10 hrs)

I therefore request you a specific case may kindly be started against the accused lady namely Dipa Bhujel w/o Kumar Tamang of Bikashnagar PS Bhaktinagar Dist Jalpaiguri and her driver (Vehicle No-WB73F/1312) under proper section of law and arrange for investigation..
