I, Nazneen Parween, W/o. Md. Maqsood Alam, R/o. Kolkata Road, Bhujipani, P.S. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, India, would like to state that I married **Md. Maqsood Alam**, S/o. Late Md. Abdul Rasid, R/o. Soturkhana, Munger, P.S. Mufassil, District Munger in the state of Bihar, in the year 05-02-2000 according Muslim rites and customs. At the time of marriage my husband assured me that he will keep me in good condition and will lead a happy married life. The marriage was consummated and I gave birth to a male child namely Md. Anas Maqsood aged about 17 years & one female child namely Zubia Maqsood aged about 14 years. Everything was going good but the situation change after birth of my daughter. My husband and my in- laws started quarrelling with me and used filthy & slag language and insult me in front of everyone. Thereafter in the month of January 2023 my husband left for Dubai. After my husband left for Dubai for work purpose my in-laws namely (1) **Gajala Parveen @ Minti**, R/o. Late Md. Jamshed, R/o. Kolkata Road, Bhujipani, P.S. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, started harassing me mentally. With the help of (2) **Md. Mahmood Alam @ Disco**, (3) **Nashreen Prveen**, (4) **Salim Javed**, R/o. Gaziabad, Bari Maszid, Village Sadrullabad, Loni Dehat, P.O. & P.S. Tronika City, Pin No 201102, Uttar Pradesh (Prayag Raj). (5) **Rumi**, (6) **Dr. Wakil Ahmad**, (7) **Atahar Rehan**, (8) **Kasim**, S/o. Unknown, 2 & 5 R/o. Khagaria, Jalkara, beside Bara Maszid,

 different mobile numbers and instigates to quarrel with me. Their main intention is
 to anyhow throw me out of the residential house where I reside with my two
 children so that they can sell the land & the house. My In-law namely Md.
 Mehmood Alam @ Disco and Gajala Parveen @ Minti is the mastermind behind all
 this act. I am alone lady residing with two minor children and at this stage I have no
 other option left hence I came before you for justice. I have been residing at the said
 house since my day of marriage and except the above residential house I have no
 other place to reside. Because of them my husband is not talking with me. Their
 main intention is to separate me from my husband so that they can enjoy the full
 property.
