With due respect of Md. Hasniali, S/o. Kazanali, Resident of Totaram, Kamala, p.s. Naxalbari, Daijeeling, do hereby lodge this complaint with the information that on 04/07/2023 morning when my daughter named Rajia Khatoon, was moving towards Shib Mandir, Matgara from her house by her Scooty bearing No. WB 7486 1783, she was just behind a truck bearing No. WB 73C3473, while she reached at Kestapani Mani, AH02, at about 07:30 a.m., the said truck all in a sudden clutches its break, without maintaining any precaution and without giving any signal to do so and so the victim (Rajia Khatoon) didn't get enough time to manage herself and dashed with the said truck and sustained grievous injuries.

The local people took her to Dishan Hospital, from there I and my family members took her to N.B.M.C Hospital Siliguri, but she couldn't survive and succumbed to her death.

Her Post Mortem was done there as per Matgara P.S W/D case No. 689/23, dt. 05/07/2023.

As we the family members were busy in her medical treatment, so we couldn't lodge this complaint yesterday i.e on. 04/07/2023.

I hereby request you, please take necessary action as per Law against the offending truck driver.
