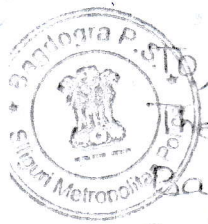

with due respect I, Fani Roy, S/o- Ashwini Kumar Roy resident of Airport More, Bagdogra, Sarjedaing, want to state that yesterday dated 06.07.23 at around 8:30 p.m, I had a quarrel with my wife namely Muni Roy (Sahani) aged 30yrs regarding some personal family issues. Meanwhile the relatives of my wife namely Sonia Sahani (Das), w/o- Kanai Das, Fekni Das, w/o- Subal Das, Sankari Das, w/o- Lt. Haren Das, Anjali Sahani, w/o- Dinesh Sahani, all residents of Gwala Busty, Airport More, Bagdogra, Sarjedaing came to my place and started beating me furiously. On seeing this my wife also started beating me with wooden sticks. I got injured in the process. Already my right arm has been fractured once, and she hit me in my hand also.
