Sir,

With due respect I would like to inform you that I Shri Jiten Chandra Roy, Father Late Kalatu Roy, Clerk Typist Gr-I, working in Joint Director, Animal Resources Development, Jalpaiguri Division at Siliguri Office. On 10.07.2023 I and my colleague Smt. Aparna Boddia, U. D. C., entered in to the office by unlocking the outer gate of the office at 10.35 a.m. While opening the lock of the gate of the main grill, I noticed that the wooden door on the right side of the office room is open to some extent. When I pushed, the door opened completely, after that I went to the office room and saw that some miscreant had broken the door hinge and entered in to the office room. Then I Check each room of the office very carefully. We saw that two office stand fans, one ceiling fan, two computer UPS and some parts of two other unserviceable stand fans and a plastic bucket were stolen. We immediately informed the higher authorities of our office over phone regarding the matter of theft. This is to also inform you that the last office day was on 07.07.2023 as 08.07.2023 and 09.07.2023 was official off day. On 07.07.2023 we came to office at 10.30 a.m. as usually and closed the office door/gate properly at 5 p.m. and leave office. Now with due permission of the higher authorities, I am requesting you to receive a general dairy and start an investigation for the same and take a proper step so that we can return back the stolen items.
