I SI HiruKanti Sarkar, O/C Milanpally Out Post under New Jalpaiguri P.S do here by lodge this written complaint to the effect that today on 07.07.2023 myself along with C/1052 Dipak Das and NVF- 041 Litan Saha were performing election law and order duty vide Milanpally OP MCC No- 998/23 dated-07.07.2023.In course of my duty at about 14.15 hrs. I received telephonic information that a group of supporters of BJP party are preparing to block Teesta Canal road at Milanpally More. I informed the matter to my O/C New Jalpaiguri PS over phone and wasting no time myself along with my accompanying force hastened to the spot to work out the information. On reaching the above noted spot at 14:20 hrs. I found that under the leadership of (1) UttamRoy of Milanpally Bazar, (2) Anup Oraow of Saraswati pure TE,(3) Susil Sarkar of Milanpally (4) Vivek Ragdar of Milanpally (5) Prosun Das of Maharajghat (6) Sujan Mandal of Dudhiya (7) Sanjit Oraow of Bhalobasha more (8) Nimai Mondal of Milanpally (9) Bibhuti Rangdar of Milanpally (10) Bappa Das of Maharajghat (11) Sujit Dey of Takimari and others approx35 supporters of BJP party starts blocking Teesta Canal road at the above noted place with their party flags and shouted slogans in favor of their demand of those of their supporter was arrested. They blocked the road of release him. Due to the blocked about 20-25 vehicles were stranded on Teesta Canal Road at the spot as free flow of traffic movement was totally stopped by the blockers. They also restricted the movement of Govt. vehicle. I told the agitators to withdraw the road blocked program but they did not pay any heed. As per order of my superiors the road blocked program was video graphed. At 16.45hrs the road blocked programme was withdrawn.

Under the above noted circumstances I pray to you that a specific case. May kindly be started against the above noted accused persons and arrange for its investigation.
