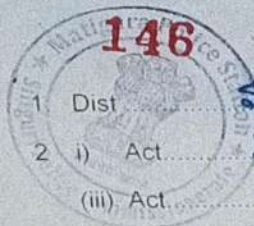

Sir,

In producing herewith 03 (three) arrested accused persons namely (i) Sanat Kumar Chettri (22), S/O- Lt. Bhim Bahadur Chettri of Jamadar Bhatta Dudhia PO-Dudhia, PS-Kurseong, Dist.- Darjeeling (ii) Aditya Gurung (24), S/O- Lt. Anil Gurung of Mirik Bazaar, PO+PS-Mirik, Dist-Darjeeling and (iii) Bijay Sahani (27) S/O Debender Sahani of Majaraj Colony ward No. 04, PO+PS-Siliguri, Dist- Darjeeling (arrested u/s- 41 Cr.P.C) along with following seized articles viz:

- (1) One iron made 'Knife' found from the possession of Sanat Kumar Chettri which was kept in his right hand.
- (2) One iron made 'Crowbar' found from the possession of Aditya Gurung which was kept concealed at his back.
- (3) One iron made 'Bhojali' found from the possession of Bijay Sahani which was kept on his right hand.

I, SI Sailesh Subba of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Sanat Kumar Chettri (ii) Aditya Gurung (iii) Bijay Sahani and others to the effect that today on 12/07/2023 at 12:55 hrs received a sources information that 8/10 youths have assembled at the backside of Vastu Bihar Apartment under Matigara PS with a view to commit dacoity in a house at Vastu Bihar Apartment. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Sanjay Basunia C/1053 Poresh Rava, and C/974 Mintu Sen, all of Matigara PS, SPC, left for the place to work out the information. At about 01:15 hrs after reaching near Vastu Bihar Apartment under Matigara PS, I met my source and being pointed by the source we started walking towards backside of Vastu Bihar Apartment. At 01:20 hrs we reached at backside of Vastu Bihar Apartment and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot. Seeing police personnel approaching towards them they tried to flee away, but on hot chase we managed to apprehend above noted 03(three) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation all the accused persons admitted that they had assembled there to commit dacoity in a flat at Vastu Bihar Apartment.

I thereafter, seized the above noted deadly weapons under proper seizure list in presence of witnesses duly acknowledged by the accused persons. The whole seizure was made in between 01:20 hrs to 01:35 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a flat at Vastu Bihar Apartment. It is also revealed from them that some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of law against the above noted accused persons namely (i) Sanat Kumar Chettri (22), S/O- Lt. Bhim Bahadur Chettri of Jamadar Bhatta Dudhia PO-Dudhia, PS-Kurseong, Dist.- Darjeeling (ii) Aditya Gurung (24), S/O- Lt. Anil Gurung of Mirik Bazaar, PO+PS-Mirik, Dist-Darjeeling and (iii) Bijay Sahani (27) S/O Debender Sahani of Majaraj Colony ward No. 04, PO+PS-Siliguri, Dist- Darjeeling and others and arrange for its investigation.
