With due respect and humble submission that I Pushpa Gupta , W/o Deodutta Gupta residing at Opposite Central Bank of India , Hill Cart Road , Ward No 11, Siliguri would like to inform you that I was married with Deodutta Gupta sin 14 years. We have one son aged about 12 years namely Devesh Gupta. During whole marriage life I have been tortured by my husband Deodutta Gupta. Since my marriage life he demand money to my father and my father always gave lum sum money to me . He did not look after me properly , not to gave family expenses. My father gave our family expenses for daily life. My husband Deodutta Gupta did not do any work till now . He took my Golden ornament about 30 gm for lending. Till date he did not return my gold . I think he sold out my ornament. He always argue with me he was threatening me to murder me by using knife. He stop the education of my son. He was not given any expenses to me for family expenditure. So I decided to do job . So I am doing one job for doing family expenditure. I lodge one complain at Siliguri Police Station since one month before but He was not change his behavior. He always assault , beaten me several time. Today (16.07.2023) he had beaten me at about 11.45 just front of my premises. He hold my neck forcibly . I went to Siliguri District hospital for better treatment . Doctor prescribe me some medicine and I left from the Siliguri District Hospital. He is always doubtful against me when I outside the house and also doing sexual harassment on me.

So Sir please lodge complain against my Husband Deodutta Gupta and take necessary action.
