**Subject: FIR**

Sir,

In producing herewith Four (04) arrested accused persons namely (i) Akash Tamang (24), S/O- Palden Tamang of Tungsung, PS Sadar, Darjeeling, Dist Darjeeling (ii) Sandeep Rai (28), S/O- Suraj Rai of New Colony, Old Matigara Road, Road No 06, PS Matigara, Dist Darjeeling (iii) Mahesh Yadav (28) s/o Bindeswar Yadav of Ujjanu, Durgaguri, PO+PS Pradhan Nagar, Dist. Darjeeling (iv) Md. Umar Faruk (22) s/o Lt. Tabarak Hussain of Gowabari, PS Jaigoan, Dist. Alipurduar arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made sword measuring 12 inch (approx.) including butt from the possession of Akash Tamang which was kept concealed on his back side.
- (2) One iron made 6mm rod measuring 10 inch (approx.) including butt from the possession of Sandeep Rai which was kept concealed on his back side.
- (3) One iron made Knife measuring 4.7 inch (approx.) including wooden butt from the possession of Mahesh Yadav which was kept concealed on his left jeans pocket.
- (4) One iron made 'Rod' measuring 9.3 inches (approx.) from the possession of Md. Umar Faruk which was kept on his right hand.
- (5) One nylon rope measuring 14 inches (approx.) in length found from the place of occurrence.
- (6) One Torch light found from the place of occurrence.

I, ASI Manoj Kumar Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Akash Tamang ii) Sandeep Rai iii) Mahesh Yadav iv) Md. Umar Faruk and others to the effect that today on 18.07.2023 at 23.25 hrs received a sources information that 09/11 youths have assembled near Panchanai River beside Salbari High School under Pradhan Nagar PS with a view to commit dacoity in a house at Salbari area. The fact was diarized in GD vide Pradhan Nagar PS GDE No-1185, dated 19.07.2023. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI- Biplab Kumar Das, CV/242 Rakesh Mangar, CV/646 Baban Das, CV/992 Jagadish Biswas left for the place to work out the information. After reaching near Panchanai River beside Salbari High School under PS- Pradhan Nagar, I met my source and being pointed by the source we started walking towards the spot and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence. However, they were about to move from the spot and seeing police personnel approaching towards them, they tried to flee away but on a hot chase we managed to apprehend above noted Four (04) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Salbari area.



I thereafter, seized the above noted weapons under proper seizure list and acknowledged by the accused persons. The whole seizure was made in between 00.35 hrs to 01.15 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons after informing the ground of arrest.

I accordingly brought the arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Salbari area. It is also revealed from them that Shiva, Md. Rohit and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz(i) Akash Tamang (24), S/O- Palden Tamang of Tungsung, PS Sadar, Darjeeling, Dist Darjeeling (ii) Sandeep Rai (28), S/O- Suraj Rai of New Colony, Old Matigara Road, Road No 06, PS Matigara, Dist-Darjeeling (iii) Mahesh Yadav (28) s/o Bindeswar Yadav of Ujjanu, Durgaguri, PO+PS Pradhan Nagar, Dist. Darjeeling (iv) Md. Umar Faruk (22) s/o Lt. Tabarak Hussain of Gowabari, PS Jaigoan, Dist. Alipurduar (vii) Shiva (viii) Md. Rohit and others and others and arrange for its investigation.
