Sir,

I ASI Dindayal Mondal of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 18.07.23 around 16.15 hrs, while on duty at Sevoke More, H.C Road found one (1) TOTO without any registration number stationed near Sevoke More, H.C Road in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Fazrul Islam (29 yrs) S/O Lt. Tousad Alam, Vill- Tapagaon, P.O- Daspara, PS-Cl. Dist-U/Dinajpur Further on being asked to produce relevant document in support of their c of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
