Darjeeling-734001 for committing of unauthorized use of electricity at their premises, u/s-135(1)(a) and 138(1)(b) of Electricity Act 2003 as amended in 2007.**

Sir,

I, Sri Tapas Bishui, S/O-Late Birendra Nath Bishui, Assistant Engineer & Station Manager, Siliguri Town CCC, WBSEDCL under Siliguri P.S., empowered by the Electricity Act 2003 (Amended Act 2007) do hereby lodged this complaint against Shiv Shankar Agarwal, S/o Lt. Prabhu Dayal Agarwal for committing the use of electric connection by means of unauthorized draw of the energy to a temporary disconnected premises U/S 135 (1)(a) and u/s 138(1)(b) of the Electricity Act 2003 read with Amended Act 2007 as stated here under. The connection exists in the name of Shiv Shankar Agarwal from which the line was drawn to his rented shop at 1<sup>st</sup> floor, Raj Music, Seth Srilal Market, Siliguri.

On 18.07.2023 at about 01:35 PM, the undersigned along with Sri A. Mahandeo, D.E. (S&LP), Pranab Sikder, SO (S&LP), Darjeeling Region, Subhradip Biswas, Sr. O.E., Sri Rabi Chettri, HG. Sr. LM. attached to Siliguri Town CCC and others technical person Conducted one surprise checking at the premises of Sri Shiv Shankar Agarwal, Raj Music, 1<sup>st</sup> Floor, Seth Srilal Market, Siliguri, Darjeeling, where the accused person Shiv Shankar Agarwal, S/O Lt. Prabhu Dayal Agarwal was using the electric power in a unauthorized way by reconnecting the temporary disconnected energy meter of sl. No. L05487468(Con ID-402427143). During inspection, we found the total calculated load is 01.2 KW and it was using for commercial purpose. Details process of theft is enclosed with Inspection Report.

As the theft of Electricity was detected during inspection in our presence and the representative of those accused persons has committed the offence and liable for prosecution U/S 135 (1)(a), 138(1)(b) of Indian Electricity Act 2003 read with amended of electricity Act, 2007. So, I seized the above meter in presenting seizure list in presence of Subhradip Biswas, Sr. O.E., Sri Rabi Chettri, HG. Sr. LM., Siliguri Town CCC and duly signed by the witnesses and taken into my custody. Copy of the Notice, Inspection and the seizure list received by the accused person.

**This complaint will be treated as F.I.R. u/s 135(1) (a) & 138(1)(b) of Electricity Act 2003 against Sri Shiv Shankar Agarwal.**
