was solemnized with Vikash Goyal s/o Vinod Goyal of  
above noted address 10 Feb 2015. Out of the marriage  
I have a 17 Months baby. However, since marriage  
my husband namely vikash Goyal and my mother in law  
Kiran Goyal has been harassing and torturing me  
physically and mentally. I am going through physical  
and mental pain everyday because of it. All responsibility  
is on me as my husband is not providing for me and baby.  
As my baby is very young, and also I am having health  
issues I am unable to work myself and depend on  
my husband but he totally neglects me and my  
baby. I have been subjected to several times physical  
tortures and verbally assault by my husband and  
my mother-in-law. They use strong words. Sometimes  
father-in-law <sup>vinod Goyal</sup> also tried to pushed me back to get  
out of the home. I got several injuries during the  
periods. Hence I request you to please look into the  
matter and save me from this situation. I am unable  
to do anything. Please help me to get a safe life.
