Respected sir,

I, Puja Yadav (Mahato), W/O Goutam Kumar Yadav, resident of Vivekananda Road, Ward No. VII of S.M.C, P.O & P.S. Siliguri, Dist- Darjeeling would like to inform you the following facts:-

1. That Goutam Kumar Yadav, S/O Late Basudev Yadav resident of Gobinda Nagar, P.O. Champasari, P.S. Pradhan Nagar, Dist- Darjeeling is my husband.
2. That on 12.01.22 my husband drove me out from my matrimonial house after mercilessly assaulting me, my minor son aged 10 years and minor daughter 5 years . Since then, I have been living in my mother's house at above mentioned address.
3. That even after that my husband has been torturing me both physically and mentally coming to my house and assaulting me and threatening me to give divorce to him, but I denied to do so. My husband to compel me to give divorce to him forcefully took away my minor son and daughter on 12.01.22 and when I requested him to give back my children as because he would not be able to take care of him and even their studies would be hampered as they are school going children at that time he told that after 2/3 days he would give back the children to me.
4. That till today he has not returned the children to me. My husband is not taking proper care of the children. Most of the time he stays out of the house and leave the children on the mercy of others.

There is none in my husband's house to look after my children. They are spending their like orphans. Their lives are being spoiled.

5. That my son and daughter however, managed to call me and on phone they were crying and told me to take them with me.
6. That hearing their cry I again requested my husband to hand over our children to me otherwise they would die but my husband adamantly told that until and unless I give him divorce he would not return my child to me nor allow me to meet my children.
7. That again on 18.07.2023 at about 4 p.m. (noon) my children called me to take them back with me they do not want to live with their father and I went to my husband's house to bring them back at that my husband abused me and drove me out from there and on my resistance assaulted me and told that if I again come to take my children then he would confine them in such a place that I would never be able to find them in my life.

I, therefore, request you to kindly take necessary legal action against my husband for abusing and assaulting me and recover my minor children from his clutches otherwise they would die.
