Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Bidhan Road (Near Gosthapal More) without any valid documents causing obstruction to public way.

Sir,

I ASI Ajit Singha of Panitanki Traffic Guard, SPC beg to lodge a written complaint th. 20.07.23 around 12.15 hrs, while on duty at Gosthapal More, Bidhan Road found one (1) TOTO without any registration number stationed near Gosthapal More, Bidhan Road in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Paritosh Malakar (31 yrs) S/O Bimal Malakar of Tepagaon, Dongrasani, Chopra, Uttar Dinajpur, PA-near Isckon Mandir, PS Bhaktinagar, Dist. Jalapiguri. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
