Respected Sir/Madam,

I, SMT. RASHMI AGARWAL, Wife of Sri Nitin Agarwal, Daughter of Ramesh Agarwal, residing at Agrasen road, Khalpara, Siliguri-734005, Dist-Darjeeling would like to inform and request you as follows:

That I got married to one Sri Nitin Agarwal, son of Mangal Chand Agarwal, resident of Agrasen Road, Khalpara, P.O. & P.S. Siliguri, District - Darjeeling on 24th February, 2014 at Siddhi Vinayak Banquet Hall, S.F. Road, Siliguri and after our marriage I started residing with my in-laws at Blue Berry Apartment, near Cosmos Mall, Siliguri and I continued to reside there till 18 months of our marriage. Since the very beginning of our marriage my in-laws, Mangal Chand Agarwal(Father-in-law), Bimla Agarwal (Mother-in-law), Ritesh Agarwal (Brother-in-law) were very unhappy with our marriage and started taunting me with filthy languages over petty things and forced me to do all household chores without any help of anyone and never let me go out and do any kind of job.

That in the month of July, 2014 my husband suffered a huge loss in his business at Golden Plaza and was forced to leave our earlier residence situated at Blueberry Apartment, near Bottle Company, Sevoke Road, and my in-laws also went back to Nepal and I along with my husband started residing at a small rented apartment situated at Agrasen Road, Khalpara, P.O. & P.S. Siliguri, District - Darjeeling. Having no option for living I along with my husband started a new business under the name and style of 2014 'SHREE BALAJI' at Seth Sreelal Market, Ward No. 11, Siliguri by taking loan from my friends and relatives and using whatever little savings I had then and said business is under my name as Trade License was issued in my name and I have been running the said business but my in-laws were not happy and dissatisfied with me and called my husband and pressurized him to not let me work my business and told him that I being wife should only engage myself in household chores and take care of our children and that is only my job due to which I was facing mental torture day

by day but due to my constant efforts and hard work my business was slowly gaining pace and it started to do good for a 4-5 years but all of a sudden in the year 2020 my in-laws shifted back in Siliguri and as our rented apartment was not spacious enough to accommodate them so they started residing at flat in Sevoke Road. That throughout the entire period of 2015 to 2019 my in-laws did not assist me nor did they invest a single penny in this said business but after shifting to Siliguri they started visiting our residence regularly and started forcing my husband to make me quit from my own business and forced me to stay in home and when I refused to listen to them they started abusing me filthy languages and tortured me mentally and even pressurized my husband to control me and that he as husband can go to any extent to shut me if required. After listening to my in-laws my husband under my in-laws influence started regularly assaulting me and beating me and when I did not listen to him he threw me out of our residence. It would be worthy to mention here that my husband is always busy over the phone the entire time over uninterrupted and repeated phone calls from unknown phone numbers and I suspect that he has affair with another woman. That since a long time I have been facing immense torture and pain and all my endurances have failed and I am in fear that my in-laws and my husband can go to any extent to torture me and harm me and my life.

You are, therefore, requested to kindly take immediate and necessary action against above-named persons.
