Sr,

I, Smt. Neelam Jaiswal, wife of Sri Dhanjee Prasad, presently residing at Jyotinagar, ward no. 4 of Siliguri Municipal Corporation, Siliguri, Post Office- Siliguri Bazaar, Police Station- Siliguri, District Darjeeling, Pin- 734005 would like to draw your kind attention to the fact that I was married to Sri Dhanjee Prasad son of Sri Rameshwar Prasad, resident of Luksan More, Post Office- Keram More, Police Station- Nagrakata, District- Jalpaiguri, Pin- 735205 on 28.11.2019 at Utsab Banquet Hall, Tumbajote, Matigara as per hindu rights and customs.

When our marriage was fixed there was no demand from my in-laws side. My in-laws stated to my parents that whatever you want to give you can give to your daughter but as the date of the marriage came closer my mother-in-law (Smt. Shaili Devi), brother-in-law namely Sri Narayan Prasad and sister-in-law (wife of Sri Narayan Prasad) namely Smt. Nitu Kalwar @ Prasad started demanding absurd amount of money/cash, bike, furniture, gold, etc and my parents were left with no option but to agree to their terms and conditions to save their respect in the society and was forced to take loan and pay Rs. 2,50,000/- (Rupees Two Lakhs and Fifty Thousand) only (i.e. Rs. 2,00,000/- transferred to Sri Narayan Prasad and Rs. 50,000/- in cash) along with furniture and gold.

Soon after reaching my in-laws house I was greeted with words insulting me and my family members for not giving enough dowry and within a week they started physically hitting me, slapping, pulling my hairs and even broke my mobile and I was not allowed to communicate with my family members.

In the month of march, 2020 my father and brother reached to my in-laws house to settle the issue but my in-laws became very furious and pushed my brother and father outside the home and they left. In the meantime lockdown was declared and later on, on 10.06.2020 my father came and took me along with him.

Further in the month of August, 2020 my husband started sending me vulgar message and started using my Facebook account and posted edited vulgar photo of mine and to the effect I lodged a Fir against him at Cyber Crime Police Station, Siliguri.

From the month of November, 2020 My husband started coming to my parents home and started showing care for me with a request to go with him to my in-laws house and in the meantime a baby girl was born out of our wed lock in the month of September, 2021 and after one month I went back to my in-laws house thinking that every thing will be fine this time but once again I was wrong and their behavior remained same and I was again subject to mental and physical torture by my husband and in-laws and in the month of April, 2022 when I was pregnant my husband at the instruction of my mother-in-law and sister-in-law left me to my parent home with an instruction to abort the child and all the medical expenses were born by my father. After the abortion my husband again started coming to my parent home took me to my in-laws house where I was subject to more cruelty and torture and they even tried to kill me by pressing my neck and later my husband dropped me to my parent home stating that once he settled all issue with my mother-in-law, sister-in-law and brother-in-law he will take me to my in-laws house and

child and as per my husband instruction I aborted second time inspite of being advised by the doctor to abort as it can cause life risk to me.

Now my husband started using slang language at us at my father, brother, mother phone from different numbers and has been mentally harassing me. From the day I married I have been subjected to mentally and physically torture by my husband, mother-in-law, brother-in-law and sister-in-law and being left with no option I have come before you to kindly save me from their torture.
