I, Smt Nirmala Thapa (60 Yrs) W/O Sri Kishore Thapa of Kalamjote, PS Matigara, Dist Darjeeling would like to state that my father Lt. Krishna Prasad Chhetri was purchased the land having Khatian No. 4/9, Mouza- Kalam, Plot No. 63 in the year 1994. I am residing with my family in the same plot by constructed my residential one storied building. Western side of my house one Anand Thapa build his residential house and for the entrance of their residence they used my land. I along with my husband both are senior citizen and for the purpose of security reason we want to construct boundary in our land. In this context, several times I was talked with Anand Thapa regarding the construction of boundary of my land he ignores me. 04.07.2023 Anand Thapa and I both were called land surveyor (Amin) for measuring the land and demarcation the land. As per demarcation of land, on 11.07.2023, I was started to construction of boundary wall by labour that time Anand Thapa S/O Lt. Man Bdr Thapa, Kapil Gurung son in law of Anand Thapa and Anita Gurung W/O Kapil Gurung entered into my land and started abusing and threatened me as I was alone in the my house. They also obstructed the construction work of boundary wall. Since then they are continuously threatened me to do not construct the boundary wall otherwise they will destroy other residential properties. That time I was not submitting any complaint due to fear as they were continuously threatened me.

Therefore, I as a senior citizen fervently request you to take necessary legal action against Anand Thapa S/O Lt. Man Bdr Thapa, Kapil Gurung son in law of Anand Thapa and Anita Gurung W/O Kapil Gurung all of Kalamjote, PS Matigara to spend our life smoothly.
