I Smt. Sabitri Chhetri, W/o - Shri Ganesh Chhetri, Vill - Kalam Jote, P.O. - Sushruta Nagar, PS. Matigara, Dist. - Sarjeeling, would like to state to you that today when my husband went to State Bank of India, NBMCH Branch at 11:10 am and I was out of our residence to see doctor and after returning we found that our front gate lock was broken and the locks of the showcases inside our house to be broken. We found the gold jewellery, other valuables and some amount of money stored in the show cases to be stolen. Nearby CCTV footage shows an unknown man entering our compound jumping over the boundary wall at 11:28 am. As a result of this unfortunate incident, we are presently feeling insecurity and facing helplessness.

In this regard you are requested to lodge an F.I.R. and take necessary actions so that the the culprit(s) is/are arrested and our gold jewellery, valuables and money can be returned to us and oblige us thus.
